










• In 1956, Leon Festinger and colleagues published When Prophecy Fails, describing their field research on a small occult group in Chicago believing in an approaching apocalypse brought about by a flood before dawn on December 21, 1954. The researchers were particularly interested in how the group would deal with prophecy disconfirmation. Build groups. Search online to find out more about the results of the case study. Definitions

- Stories about obscure plots by powerful elites to serve their malevolent interests, while the unaware and naive population is at their mercy (Douglas et al., 2017)
- Conspiracy myths challenge official accounts and narratives about events (Harambam, 2021)
- A symptom of complexity: People adhere to easy explanations for contingent social processes involving mighty puppet masters to reduce the complexity of a world by which they are overwhelmed (Törnberg, 2018)

Some of the most viral posts targeting war-afflicted Gazans have used the term "Pallywood", a derogatory label blending "Palestine" with "Hollywood."

"This trend initially emerged in the early days of the war, with a video revealing the behind-the-scenes of a film set and alleging it portrayed Palestinians fabricating injuries," Yotam Frost, from the Israeli disinformation watchdog FakeReporter, told AFP.
